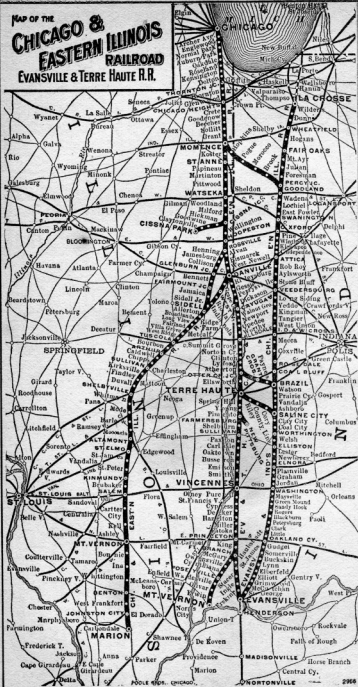


**MAP OF THE
